Land being a touchy subject within our jurisdiction, disputes often arise out of the transactions where land is involved. The nature of the disputes ranges from land use through to the acquisition process.

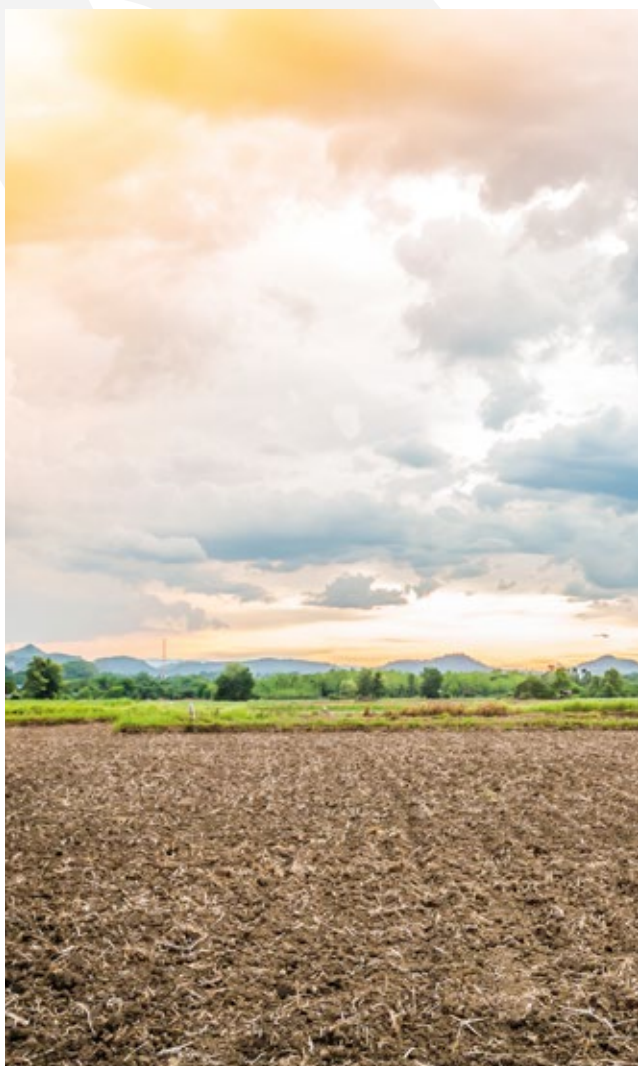

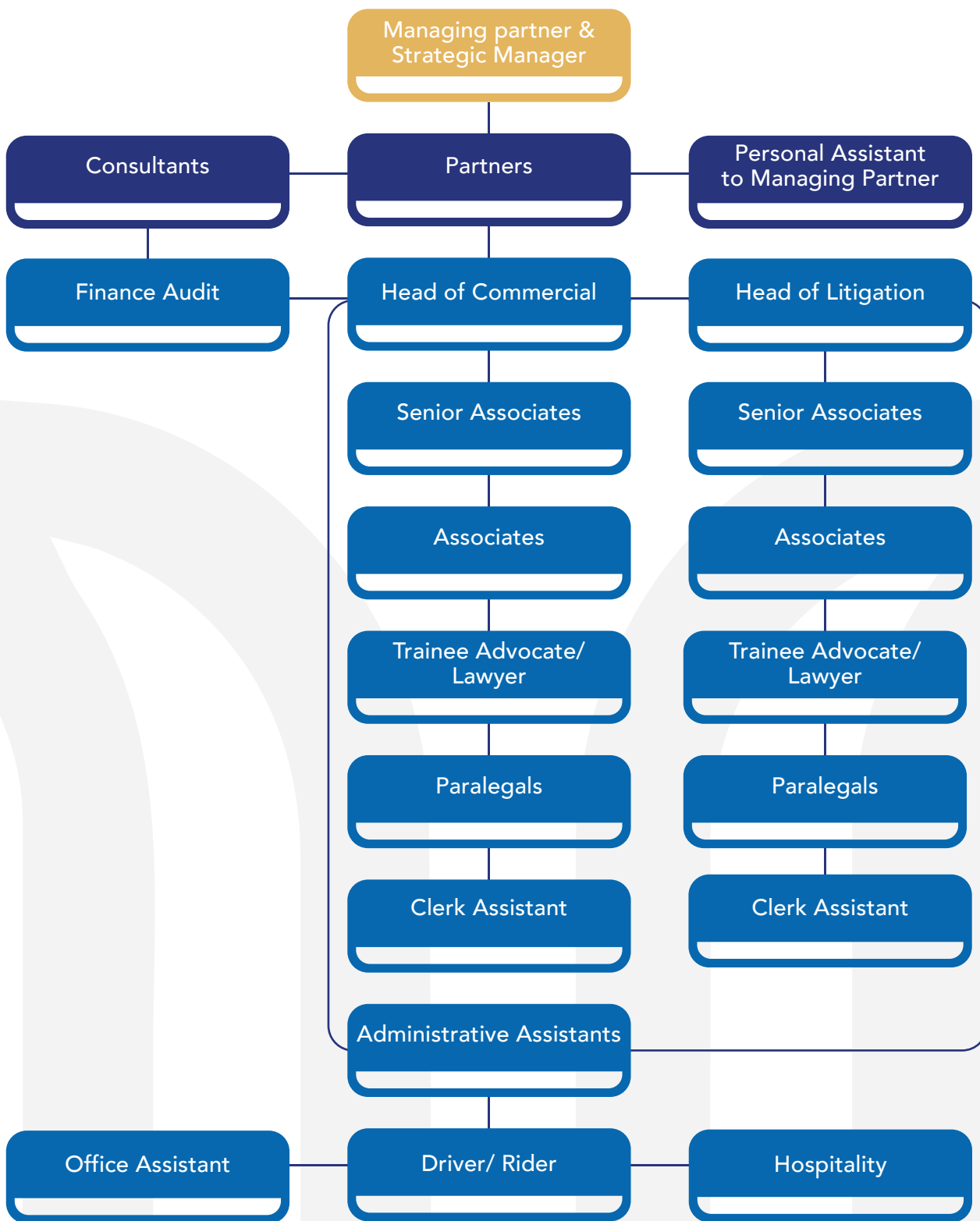
